BUSINESS PROPERTY RELIEF - DO YOU QUALIFY?

Business Property Relief (BPR) was established to provide the UK's SME sector with some protection on the event of the death of the principal shareholder. It was established to help companies and beneficiaries to continue trading when faced with an inheritance tax liability that could end up forcing a sale to cover the bill. BPR can offer up to 100% relief from inheritance tax, a potential saving of 40% on the value of the business. If you're a family-owned or small business, read on to find out more about qualifying for BPR.



- Capital employed
- Time
- Turnover
- Profit
- Overall context

Considering all of these elements means that a trading business is allowed to, in some circumstances, own investments e.g. a rental property or listed shares, provided the above tests favours the trading business.

However, advice should be taken to ensure this is the case and if not, seek guidance on how to restructure the business so the relief is not lost.

3. Will the value of the whole business qualify for relief?

Some assets will be excluded from BPR, even if the remainder of the value of the company qualifies for it.

This is the case if the company has a large sum of cash or other assets not used for the purpose of the business which:

- Have not been used for the business throughout the two years before the transfer
- Are not required for future use in the business.

It is a good idea to consider this on an annual basis and keep regular notes of the purpose of the assets, for example if it's earmarked for a specific trading project, to maximise the relief.

Do you qualify?

Any interest in a business can qualify for BPR provided it meets certain criteria. This includes shares in a limited company or an interest in a partnership or a sole trader's business. Other assets owned for the purpose of your business can also qualify, sometimes at a reduced rate of 50% subject to certain caveats.

Understanding if you qualify can be tricky, here are the top four criteria to consider:

1. Minimum period of ownership

You must have owned the business interest for a minimum of two years.

One benefit of the legislation is that if you have sold your qualifying business, you can benefit from the relief by investing in a replacement business which qualifies for relief, even if you have not owned that new business for two years.

One trap to be aware of is that whilst a transfer between spouses made on death will mean that the surviving spouse inherits the ownership, this is not true for a transfer made during lifetime, even between spouses.

2. How HMRC decides if a business qualifies for relief

Often business will have a mixture of assets used for trading and investments. The important point is that the business is not 'wholly or mainly' an investment business. For example, it must not consist wholly or mainly of the following:

- (i) Dealing in securities, stocks or shares;
- (ii) Dealing in land or buildings; or
- (iii) Making or holding investments

The business must not be subject to a binding contract for sale

Usually a binding contract for sale will be obvious, but there is another trap here where agreements are made for business interests to be dealt with in a particular manner on death.

For example, if a Shareholders Agreement. states that on the death of one of the shareholders, the personal representatives must sell the shares to surviving shareholders, this could constitute a binding contract for

The effect would be that even if the shares qualified for business property relief in every other way, the relief would be lost on death.


To achieve the same objective whilst still qualifying for relief, 'put and call' options can be put in place instead. It is sensible to review your documents to ensure that you do not inadvertently lose the relief.

There are specific rules for group companies to consider too so they should also seek legal

For SME business owners, it is a good idea to have a regular 'health check' for your business to ensure it will qualify for BPR from inheritance tax.

The key things to look out for include: is there a significant amount of investment activity or a large sum of cash in the business? Or, are there agreements as to what happens on death which may restrict the relief?

No business should assume it qualifies for 100% BPR, but reviewing the above four points should help you understand more about the criteria for qualification.


Management, Roman Lodge Holdings and Richborough Estates.

Burns Garages Celebrating

100 years of business 1918 – 2018











Robert Burns reflects on 100 years of business.

Our upcoming anniversary has given me the opportunity to reflect on our history and the achievements we have made to make the business what it is today. I am very proud to be the current custodian of a 100 year old business!

My Great Grandfather Robert (Bobbie)
Burns came to Congleton in 1914 from
Manchester, where he had been in charge
of vehicle assembly at Crossley Motors.
On arrival in Congleton he became a
partner at Wadesons (previously Hiskins
& Wooltorton), a business specialising in
building and repairing horse drawn vehicles.
These vehicles were held in high regard with
several being exhibited at Crystal Palace, the
forerunner of today's Motor Show.

In 1918 Bobbie bought out Thomas Wadeson, starting the Burns Garages journey. With increased demand for motorised transport and Bobbie's understanding of the need for excellent customer service, the business soon flourished. Today our staff continue to abide by Bobbie's philosophy of complete customer satisfaction.

My Grandfather Harold, Mayor of Congleton in 1972, will perhaps be best remembered for his exploits with the Flying Flea, an aeroplane constructed at the Garage and flown (& crashed with frequency) from Back Lane.

Continuing in the family trade, my Father Ian joined the business in the early 1960's. At this time the business moved into our current locations of Canal Street & Radnor Park Trading Estate and saw a dramatic increase in sales.

Today, my focus remains on customer satisfaction, and I'm very proud that we have won the prestigious Ford Motor Company Chairman's Award 6 times in recent years. We continue to expand and invest in our business and I look forward to continuing this journey.

A round-up of news from across the network.

Cyber Crime

Protect your business by protecting yourself

The risk to businesses from cyber-attacks (cyber-crimes) is significant and growing.

The threats include:

- Ransomware Malicious software (malware), which prevents access to data until a ransom is paid.
- Denial of Service (DoS) –
 Caused by numerous requests sent to a server from 'bots' infected by malware.
- Phishing Emails that appear to be from genuine businesses e.g. PayPal, which will install malware on your device if a link is clicked or attached file is opened.

If individuals are aware of these threats, and know how to protect themselves, half of the battle against cyber-crime is won.

Good, non-technical security practices, have the potential to reduce the risk of a successful cyber-attack by up to 80%.

Follow these three simple steps and you can mitigate a large proportion of attacks:

- 1. Use strong passwords; don't use the same one for everything, and never share your passwords.
- 2. Keep your device updated.


3. Install and keep up to date suitable anti-virus and/or anti-malware software

If you become a victim, Action Fraud is the UK's national fraud and cyber-crime reporting centre.

To report a cyber-crime go to www.actionfraud.police.uk/report_fraud, or call 0300 123 2040. Action Fraud is not an emergency service, so if you feel you need an immediate response, call 101 or 999 if you or your businesses are in immediate danger.







Cheshire Fire and Rescue Service has a dedicated team to help businesses across Cheshire East to stay safe from fire.

The business safety team is led by Business Safety Manager Tracey Carter and the aim of the department is to help businesses understand their legal obligations under the Regulatory Reform (Fire Safety) Order 2005 which came into force on October 1st 2006.

Business Safety Advocates Sarah Marshall and Sandra Buckle can advise businesses on how the tackle the threat of arson, and assisted by volunteer Bob Briscoe, they carry out a program of business safety reviews, which act as a pre-audit checklist. This helps companies prepare for official fire safety audits which ensure the safety of premises, should a fire break out.

Tracey Carter said: "By supporting businesses we hope to relieve some of the anxiety surrounding the audit process. All businesses need to comply with the Fire Safety Order and we are here to help. My team will go out and visit businesses personally and provide help and advice where needed, to ensure the safety of the business but also that of its staff and visitors."

"During these visits it's a good opportunity to remind employers to review fire risk assessments and training and make sure existing staff know the importance of fire safety."

Overall the latest trade statistics show that UK exports of goods and services have increased - exports stand at £547.6 billion, up 5.8% on 2015.



On a more seasonal note......


You can find UK holiday exports in travel destinations around the world. Last year alone, more than £300 million worth of these goods were sold to shoppers across the globe showing increasing demand for home-grown summer essentials.

Sunglasses remain one of the top holiday exports, with £3.8 million worth sold to Hong Kong, £4.6 million worth of UK swimwear sold to the USA and more than £1.4 million worth of flip-flops sold to non-EU countries.
