From the 17th to 19th January 2025, a dedicated team of adventurers took on a gruelling three-day, 40-mile Arctic trek, raising a significant amount for The Joshua Tree, a Cheshire-based charity supporting families affected by childhood cancers.

The Arctic Challenge saw the team endure freezing temperatures as low as -20°C, haul heavy sleds across frozen terrain, and camp under the stars in one of the world's harshest environments. The challenge tested both physical and mental limits, and their shared determination has resulted in a significant difference to the charity and the families it supports.

Driving forward the group was Rich Driffield. CEO of The Joshua Tree, who took on the challenge alongside fellow members of the East Cheshire Chamber of Commerce: Jake Pear and Chris Baldwin, Directors of Pear Hospitality, and Will Cliff, Head of Elite Sport, Franklyn Financial Management.

"The Arctic Trek was an incredible experience and one I will never forget," said Rich Driffield. "The scenery was spectacular, the challenge was immense, and the funds raised will make a real difference. I'm so proud of what we achieved together."



Jake Pear described the experience as "a journey that pushed all of us to our limits. There were some tough moments, but doing it all for The Joshua Tree gave us the motivation we needed. Crossing the finish line was electric—a once-in-a-lifetime experience."

Will Cliff added, "Friends made for life, stories to tell for years to come. The sights we saw—including the northern lights and rainbow pearl clouds—were just incredible."

Chris Baldwin reflected on the physical challenge: "Pulling the pulk was tough, especially during the steep climbs, but the incredible team spirit made the entire journey unforgettable."

Supporting Families, Changing Lives

The Joshua Tree provides bespoke emotional and practical support to families affected by childhood cancers across North West England, and North Wales. With over 380 families currently accessing their services—and the demand for support continuing to grow—the funds raised from this challenge will directly support vital services, including counselling and wellbeing sessions, art and play therapy for children, sibling support, peer support groups, and family events.



"As CEO, I see firsthand the impact our support has on families. That's why I took on this challenge—to ensure we can continue to be a lifeline for those navigating the unimaginable," said Rich.

Get Involved

The Joshua Tree relies on grants, donations, and community fundraising to deliver its services. This challenge is a powerful example of what can be achieved when communities come together for a cause.







Cheshire Community Rallies to Secure Future of **Domestic Abuse Services**

Local domestic abuse charity MyCWA (known as Cheshire Without Abuse) has successfully avoided the closure of its survivor support services thanks to a remarkable outpouring of community support, raising over £462,000 following an emergency public appeal launched in January.

The charity, which has supported survivors of domestic abuse across Cheshire for 47 years, faced a critical funding shortfall with key service contracts due to expire on 1st April. Without urgent financial support, MyCWA risked shutting down its helpline, support centre, and recovery programmes.

In just three months, the appeal was met with overwhelming generosity from local residents, businesses, funders, and community groups. This response has enabled MyCWA to continue delivering a range of essential services, including a 24/7 helpline, therapeutic programmes for adults and children, and practical support such as food, clothing, and baby banks.





Cheshire East Council to fund 16 refuge spaces—a major step in sustaining safe accommodation provision across the region.

MyCWA Chief Executive, Saskia Lightburn-Ritchie, said:

"We are deeply grateful to every individual, business, and funder who stepped forward to support us. This incredible show of community solidarity has ensured that survivors of domestic abuse will continue to find safety, support, and hope through our services."

While the immediate crisis has been averted, MyCWA continues to work toward long-term financial sustainability to ensure its vital services can continue well beyond the next 12 months.

I invited around 100 senior business leaders and public sector partners from across Cheshire, to an exclusive event, in which we co-create a new employment programme for ex-offenders.



I am keen to use my position as Police and Crime Commissioner, to do things differently. I'm eager to try and provide different opportunities to find solutions for problems we face across Cheshire.

We shouldn't accept that 50% of prison leavers will (on average) re-offend within three years. This cycle ruins lives, costing the country over £18bn a year. Money that could be used to fund intervention and prevention initiatives.

Evidence shows that when ex-offenders are offered meaningful career opportunities, where they can develop in a professional capacity, they transform their lives and integrate better into a law-abiding society.

Around 3,000 people are managed by probation in Cheshire. About a third of these are looking for employment or training. Meanwhile, brilliant businesses across Cheshire have been telling me that they're crying out for loyal, motivated and reliable employees. Research by New Futures Network has shown that's exactly what ex-offenders can be, given the chance.

At a time when we're being asked to deliver more with less, I'm looking for new ways to bring the right people together who have a stake in Cheshire's success, both businesses and those working with offenders.

With the support from Probation, the Department of Work and Pensions and businesses, I'll drive this forward. My aim is to launch the programme in the Autumn and get 100 ex-offenders into employment in 2025.

Once this aim is met, the programme will be evaluated, enabling us to learn what went well and what didn't, before expanding.

If we do this right, it will make a real difference in Cheshire, preventing crime, reducing re-offending, solving workforce shortages and turning offenders into workers.
